1. Call to Order

The meeting was called to order at 2 p.m.

2. Approval of Minutes: May 8, 2018

The Committee approved the minutes of the May 8, 2018 meeting.

3. Citizen Communication: None.

4. Consider Approval of the 2019-2022 Transportation Improvements Plan (TIP) a. Staff Briefing

Ms. Bergeron noted in the FY 2019-2022 TIP there are two projects that are scheduled to begin construction in 2020 and 2021. In the fiscal year 2020, US 59 from US 87 to SH 185 is scheduled to begin construction of frontage roads. In the fiscal year 2021, SL 463 from Business 59 to Lone Tree Road is scheduled to add two additional lanes to create a continuous four-lane highway along SL 463.

b. Public Hearing

Mr. Halepaska opened the public hearing. There were no comments, so the public hearing was closed.

c. Formal Action

Skip Kaup made a motion to approve the final FY 2019-2022 Transportation Improvement Plan. Jan Scott seconded the motion. Motion carried.

5. Consider Approval of the 2018-2019 Unified Planning Work Program (UPWP) a. Staff Briefing

Ms. Bergeron stated that in the Unified Planning Work Program there were some changes that were highlighted in the agenda. She stated those changes are highlighted in yellow in the Budget Summary. The only changes in the UPWP are in Task 4 in which the total is \$226,300. The carryover for FY 2019 is \$203,643.57 and the total Transportation Planning Funds is \$387,337.47.

b. Public Hearing

Mr. Halepaska opened the public hearing. There were no comments; the public hearing was closed.

c. Formal Action

Donald Reese made a motion to approve the Final FY 2019 Unified Planning Work Program. Charmelle Garrett seconded the motion. Motion carried.

6. Consider the Adoption of a Resolution for GCRPC's Transit Asset Management Safety Performance Measures

a. Staff Briefing

Ms. Bergeron noted that the Transit Asset Management Plan prioritizes funding based on the condition of transit assets. The reason why the MPO is going to adopt it as a resolution is it goes towards our target safety performance measures within the MPO and allows collaboration with our partner Golden Crescent Regional Planning commission. Ms. Bergeron noted the asset class includes equipment, rolling stock and facilities which would be age, mileage and condition. She noted they needed to maintain a score between 2.5 and 5 to maintain that state of good repair.

b. Discussion – None.

c. Formal Action

Jan Scott made a motion to approve the Resolution to adopt Golden Crescent Regional Planning Commission's Transit Asset Management Safety Performance Measures. Skip Kaup seconded the motion. Motion carried.

7. Consider approval of the contract between the Victoria MPO and the Texas Department of Transportation (TxDOT), and the City of Victoria

a. Staff Briefing

Ms. Bergeron stated this contract clearly states the responsibilities of each of these agencies as well as the policy committee, myself and the City of Victoria which acts as the MPO's fiscal agent. She stated that we all must maintain state and federal compliance. Julie Fulgham stated that this contract will also have to go before the City Council for approval and is scheduled for the June 19, 2018 meeting. This contract is good for a period of six years.

b. Discussion

Ms. Scott asked if this would really change anything. Ms. Fulgham stated it is just making sure everyone is on the same page and the public is informed.

c. Formal Action

Charmelle Garrett made a motion to approve the contract between the Texas Department of Transportation, the City of Victoria, and the Victoria Metropolitan Planning Organization. Donald Reese seconded the motion. Motion carried.

8. Transportation Program Reports

a. Victoria Transit

Lisa Cortinas stated they still have Partner in Agency buses and all of the old buses that were damaged have finally been towed away. She noted they did get notice from FTA on the funds that will be used to replace the buses. They are transferring over from Federal Highways CMAQ funds to replace the buses.

b. Highway Projects

Michael Brzozowski stated Hwy. 87 at Nursery, frontage project at the Loop and the Hanselman overpass would be completed in the next month and a half. He stated for the frontage road project at Telferner and the Loop, he has not received the authorization to work. Once it is received, we will contact the contracator and get started.

c. Victoria Airport

Mr. Llerena stated they had four very solid proposals for air service. They have narrowed it down to two. He noted both would co-share with United Airlines in Houston. The one proposal is a 46 passenger aircraft and the other one is corporate style and first class inside, but is only 8 or 9 passengers. The airport is looking at which direction they want to go. He noted they will have to have a decision made by July 13, 2018.

d. Port of Victoria

Skip Kaup stated they are still working on road infrastructure and they have finished with Old Bloomington road. They have completed the part they needed to finish on 1432. Canal road is also finished all the way down to the bridge and they are working on McCoy Road.

9. Items from MPO members

Julie Fulgham stated they are applying for a Build Grant. The BUILD Grant replaces the TIGER Grant. They are very large grants administered through the state. She noted they would not need any action through the Policy Committee, but it would be taken to City Council. She stated they would not need to have an MPO meeting until September.

Maggie Bergeron stated the BUILD grant does replace the TIGER grant. The BUILD grant has added criteria. The criteria are safety, good repair, economic competitiveness component, environmental protection, quality of life, innovation, partnership and for this project would need to show that there is non-federal revenue for infrastructure investment. She stated those are the criteria to be awarded a very

competitive federal grant. She stated in April 2018, \$1.5 billion dollars was set aside for this grant program. She stated now we are writing the narrative for an improvement to Guy Grant Road, south of the Salem Road which would intersect all the way until it hits east Mockingbird. The proposed improvements to the road would be creating a 3-lane roadway and then building a shared use hike and bike trail along the southeast side of the road. Julie Fulgham stated the cost of the project would be \$5 million.

10. Adjournment

There being no more comments, the meeting was adjourned at 2:40 p.m.

Agenda Item 4: Consider Approval of the First Amendment to the FY 2018 Unified Planning Work Program (UPWP) and Review the FY 2019 UPWP Administrative Amendment

STAFF REPORT

Subject

Approve amendments to the FY 2018 Unified Planning Work Program (UPWP) and review the FY 2019 UPWP administrative amendment.

Summary and Background

FTA Section 5307, found in 49 U.S.C. 5307, are Urbanized Area Formula Grant monies designated for urbanized populations of 50,000 or more. The funds can be used for transportation planning, engineering, design and evaluation of transit projects, and technical transportation-related studies. These grants are formula-based allocated monies where funding is based on population and population density for non-Transportation Management Associations (TMAs). Victoria Transit, through the Golden Crescent Regional Planning Commission (GCRPC), is allocated FTA 5311 funds to use for planning, capital, and operation funds. 5311 is for rural areas: The Rural Transit Assistance Program (49 U.S.C. 5311(b)(3)) provides a source of funding to assist in the design and implementation of training and technical assistance projects and other support services tailored to meet the needs of transit operators in non-urbanized areas.

In Task 3, Subtask 3.4, of the FY 2018 UPWP, the amount of \$83,125.00 is listed under FTA Section 5307. A correction is needed to indicate that these funds have not been allocated to the Victoria MPO, Victoria Transit, or GCRPC, and, was mistakenly placed in the Victoria MPO's Task 3, "Short Range Planning," as Subtask 3.4 "Victoria Transit Planning." Therefore, an amendment, approved by the Victoria MPO Policy Advisory Committee, is required to remove the \$83,125.00 in Task 3, "Short Range Planning," under Subtask 3.4 "Victoria Transit Planning."

These funds were also reported in the FY 2019 UPWP, Task 3, "Short Range Planning," Subtask 3.4/ The FTA Section 5307 funds, in the amount of \$83,125.00, was reported, but should not be included in the UPWP since these funds are not used by the GCRPC for transportation planning. Removing this erroneous reporting is an administrative amendment.

Staff Recommendation

The Victoria MPO staff recommends amending Subtask 3.4 in the FY 2018 Unified Planning Work Program (UPWP) to reflect no FTA Section 5307 funds have been allocated to the Victoria MPO or Victoria Transit.

Requested Action/Motion

Approve the amendment of the FY 2018 Unified Planning Work Program (UPWP).

Agenda Item 5: Information Administrative Amendments of the FY 2019- 2022 Transportation Improvement Plan (TIP)

Background Information

The Victoria MPO Coordinator can approve minor revisions to the TIP administratively providing that the administrative changes meet the following requirements:

- Changes to project funding category within Federal or non-Federal sources
- Changes to project priority with the funding years of the TIP
- Clarification of project scope
- Minor changes to project limits, descriptions, or scope that do not fundamentally change the change the project's function, cost, or environmental impacts

The Victoria MPO has updated one project listed in the FY 2019- 2022 TIP for the FY 2020, construction of one-way frontage roads along US 59 from US 87 to SH 185. The project was amended administratively to accurately reflect the correct project limits and location.

The remaining administrative amendments reflect changes to Grouped Projects:

- On US-59T from Ben Wilson Street to North Laurent Street the project costs decreased by \$634,072.00
- BU 77S, from Loop 463 to Airline Road, have been combined into one grouped project that will:
 - $\circ \quad \text{Resurface the roadway} \quad$
 - o Construct a median
 - o And, install lighting
- And, US 77 was amended to reflect the correct end mile point, extending the project length by half a mile. This means that the limits from begin 8.78 miles South of FM 682 and end .2 miles North of Broadmoor Street.

STAFF REPORT

<u>Subject</u>

Presentation and discussion of the 2045 Victoria MPO MTP regarding development and vision; and the formation of the 2045 Ad Hoc Committee to provide assistance on demographic and business development trends, performance-based planning criteria to meet the requirement of Fixing America's Surface Transportation (FAST) Act, and project selection for the 2045 MTP for the Victoria MPO.

Summary and Background

The current MTP for the Victoria MPO boundary was adopted in April 2015, and provided a twenty year, long-range planning horizon until 2040. As required by Federal Law, 23 CFR § 450.322, the MTP must be updated every five-years for attainment areas. The MTP establishes a cooperative, continuous, and comprehensive framework that addresses the long-range metropolitan planning requirements of the (FAST) Act, the current governing transportation Bill.

The MTP process begins in the Fiscal Year 2019, with a Request for Qualifications (RFQ) in late September 2018. The 2045 MTP will continue to use the base-year of 2012 in the travel demand model (TDM), updating the demographic data with 2017 estimates, and refresh the forecast to 2045. The MTP will identify the transportation needs of the community, demographic trends that impact the transportation network, and identify a list of fiscally constrained projects to be implemented over the twenty year horizon for the Victoria MPO boundary.

The Victoria MPO staff believes that the MPO Policy Advisory Committee can contribute in providing an overall vision for the 2045 MTP. The Committee's vision will provide guidance in performance-based planning criteria and project selection. The guiding vision will support the creation of a comprehensive long-range transportation plan and allow for the continued development of an effective and sustainable transportation network in Victoria.

The Victoria MPO staff believes that an Ad Hoc Committee for the 2045 MTP should be established to provide guidance on demographic and development trends, review drafts of completed MTP chapters, provide local knowledge to MPO staff in ways to engage the public, and, overall, provide more direct guidance in the production of the 2045 MTP.



- The 2045 MTP process is underway and will begin at the start of the FY 2019 with a Request for Qualifications (RFQ)
 - A RFQ provides consultants an outline and scope of work for the MTP
- The RFQ is scheduled to be posted to interested firms by the middle of September
 - This will allow one month for interested consulting to apply by the mid-October deadline
- Consultants will be interviewed at the end of October
 - Ideally, this is the time in which the 2045 Victoria MTP Ad Hoc Committee would want to begin convening




The Victoria MPO Policy Advisory Committee still plays a vital role in the production of the MPO's 2045 MTP.

Discussion of future amendments to the Victoria MPO 2018 Public Participation Plan (PPP).

Summary and Background

The Victoria MPO's Public Participation Plan (PPP), adopted January 9, 2018, requires an amendment providing a clear distinction between an administrative amendment, amendments requiring public participation, and/or MPO Policy Advisory Committee approval.

The proposed amendment to the current PPP will provide uniformity throughout the document regarding the public review and comment period required for all documents.
